Dr. Colin Ong is a member of the Brunei, English and Singapore Bars. He has acted as arbitrator or as counsel in over 200 commercial arbitrations under most major rules of arbitration governed under Civil and Common Law. His arbitrations generally involve cases concerning commercial matters, construction and infrastructure projects, energy disputes, finance, insurance, investment; joint venture issues; mining and minerals disputes, technology transfer and general commercial trade related matters.
